## Tax Sale letters to home owner

- 1. Make sure your 50 day list is printed or saved to pdf.
- 2. Edit your letter, this should be on your tax server as a text file (saleletter.txt) this file must be on the tax server as it gets merged with the data from the tax system.

**NOTE:** Do not save this file as a word document as the tax system will not be able to read it.

To edit click <start> <my computer> look for your user name with a reference to the tax server, double click to access your files.
